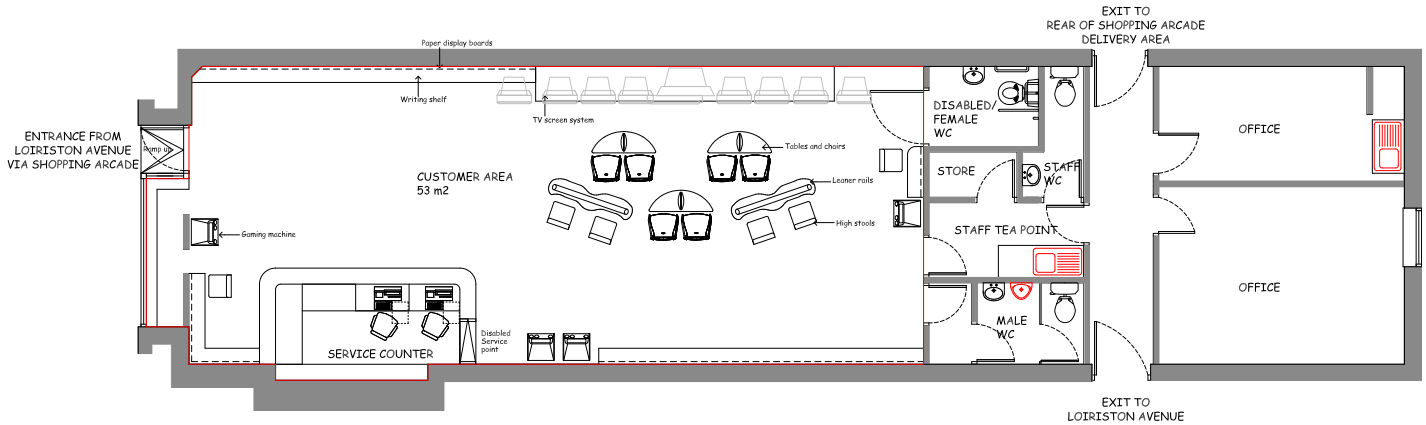
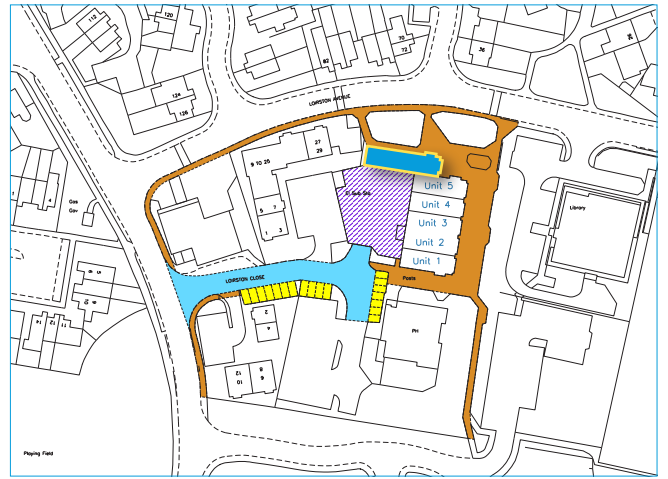

LOCATION

Cove Bay is a popular residential suburb located approximately 4 miles south east of Aberdeen City Centre, situated only a short distance from the A.956 linking to the main A.92/A.90. The subjects are positioned on the south side of Loirston Avenue at its junction with Earn's Heugh Road.
